1. Purpose

This license states the terms on which Foundation ResourceWorks (FRW) publications are supplied to purchasers. It is the single set of license terms for all FRW products and is included in every release package.

2. Scope

This license applies to every FRW publication released to a purchaser or licensee, in any format, including editable Word masters, released PDF editions, printed copies, and digital or subscription content. Individual publications reference this license and do not state terms of their own.

3. Definitions

- Licensee — The organization that purchased the publication, and its employees.
- Publication — Any FRW work supplied to the Licensee under this license.
- Blank instrument — A publication issued with positions for the Licensee to complete.
- Completed copy — A blank instrument after the Licensee has entered its own content.
- Site — A physical facility operated by the Licensee.
- Product class — The category a publication is sold in. FRW sells three: Pack Product, Individual Resource, and Free Resource. The product class is stated at the point of sale and fixes the scope of the grant in clause 4.
- Pack Product — A starter pack issued under PUB-1000, comprising the full mandatory composition required by that standard.

- Individual Resource — A single publication sold on its own rather than as part of a Pack Product, such as a poster, toolbox talk, checklist, or form.
- Free Resource — A publication FRW supplies at no charge. FRW has issued no Free Resource, and this class is reserved. Where FRW issues one, its terms are those stated with it at the point of supply.
- Nominated Site — For an Individual Resource, the single Site identified by the Licensee at purchase, or where none is identified, the Site to which the publication was first supplied.

4. Grant of License

On purchase, FRW grants the Licensee a perpetual, non-exclusive, non-transferable license to use the publication in accordance with clauses 5 and 6. The license is granted to the purchasing organization, not to an individual. The scope of use depends on the product class purchased. For a Pack Product, the license covers all of that organization's Sites. For an Individual Resource, the license covers the Nominated Site only; use at any further Site requires a further purchase for that Site, or the purchase of the Pack Product that contains the publication. Where FRW and the Licensee agree different terms in writing at the point of sale, those terms govern.

5. Permitted Use

- Complete, adapt, and reproduce the publication for use at the Licensee's own sites.
- Distribute copies, completed or otherwise, to the Licensee's own employees.
- Distribute copies to contractors while they are performing work at the Licensee's sites.
- Retain completed copies as the Licensee's own records, with no further obligation to FRW.
- Print, post, and display the publication at the Licensee's sites.
- Continue to use copies already issued after this license is revised or the publication is withdrawn from sale.
- Where the publication was purchased as a Pack Product, use it as part of advisory, consulting, or implementation services the Licensee provides to its own clients, provided the publication is adapted for the specific client engagement and is not supplied to the client, or to any other third party, as a standalone FRW product. This permission does not extend to an Individual Resource.

6. Prohibited Use

- Resale, sublicensing, lease, or distribution of a blank instrument or unmodified publication, whether or not a charge is made.
- Supplying the publication itself, in blank or unmodified form, to a client or any other third party as a deliverable, rather than using it to produce adapted, engagement-specific work under clause 5.
- Distribution to any organization other than the Licensee, except to contractors as permitted in clause 5, or to clients as permitted in clause 5.
- Removal or obscuring of the FRW document control block, document number, product code, or copyright notice from a blank instrument or unmodified publication.
- Use of an Individual Resource at any Site other than the Nominated Site, or in advisory, consulting, or implementation services provided to a client.
- Any statement that FRW has reviewed, approved, certified, or accepted responsibility for a completed copy or an adaptation.
- Use of FRW names, logos, or brand assets outside the publication as supplied, including in a way that suggests a client's deliverable is itself an FRW product.

7. Ownership

FRW retains ownership of and all intellectual property rights in the publication, including its structure, wording, components, patterns, templates, and design. Nothing in this license transfers ownership. The Licensee owns the content it enters into a completed copy, and the completed copy as a record, but not the underlying publication.

8. Third-Party and Regulatory Material

Regulatory and standards text is cited in FRW publications, not reproduced. Citation does not grant the Licensee any right in the cited material, and does not imply endorsement by, or affiliation with, any regulator or standards body. Where a publication includes third-party material under license, that material remains subject to its own terms.

9. No Warranty and Limitation of Liability

FRW publications are implementation resources. They do not certify compliance, do not replace a site-specific hazard assessment, and do not supersede federal, state-plan, local, collective-bargaining, equipment-manufacturer, or site requirements. The Licensee remains responsible for determining what applies at its sites and for implementing and verifying its own programs.

The publication is supplied as is. To the extent permitted by law, FRW gives no warranty of fitness for a particular purpose and accepts no liability for loss arising from use of, or reliance on, a publication or a completed copy.

10. Term and Termination

The license continues indefinitely unless terminated. FRW may terminate the license of a Licensee that breaches clause 6. The license granted for a publication terminates automatically if the purchase of that publication is refunded, in whole or as to that publication, whether the refund is requested by the Licensee or issued by FRW. On termination the Licensee shall cease using and distributing the publication and shall destroy or delete the copies supplied, but may retain completed copies already made as records of work already performed. Retaining such records does not permit continued use of the publication to produce new work.

11. Revision Entitlement

For six months from the date of the Licensee's purchase of a publication, the Licensee is entitled, at no additional charge, to the current released revision of that publication whenever FRW issues one. This entitlement runs from the Licensee's purchase date, not from FRW's release date of the revision, and applies to editorial, minor, and major revisions issued within the six-month window.

- The entitlement provides the updated publication. It does not extend, and is not needed to extend, the perpetual license granted in clause 4, which continues for every revision the Licensee has received.
- After the six-month entitlement period ends, a later revision is available by new purchase or under a subscription or maintenance offering, where FRW makes one available.
- FRW is not obligated to notify a Licensee whose entitlement period has ended that a revision exists, though FRW may do so.

- The entitlement ends when the license for that publication terminates under clause 10, including on refund, regardless of how much of the six-month period remains.
- Where a publication is withdrawn or revised for a safety reason, the purchaser notification in PUB-1000 clause 14 applies regardless of whether the entitlement period is current.

12. Inclusion in Release Packages

- This license is included in every FRW release package under FRW-000 Release Package Rule.
- Every publication references this license by document number, and states the copyright notice. A publication does not restate the terms. The publication does not cite a revision of this license, because the revision that governs a supplied copy is fixed at supply and is recorded in the release package that supplied it.
- The revision of this license that governs a supplied copy is the revision included in the release package, and it is identified in the package manifest and in the release record for that release. Exactly one revision of this license is included in any package.
- A citation elsewhere in a publication to the pattern, product standard, or template it was built under continues to name a revision, because that citation records how the publication was produced rather than the terms on which it is licensed.
- A publication may carry a short plain-language summary of the license, clearly identified as a summary, with this document governing.
- A revision of this license does not alter the terms under which a publication already supplied was licensed.

13. Authority

This license is issued at Tier 4 of the governance hierarchy under the authority of FRW-001 Foundation ResourceWorks Constitution, satisfies the license requirement in FRW-005 clause 9, and is controlled under FRW-000 Document Control Standard and Master Document Register.

1	2026-08-07	Added clause 11, a six-month revision entitlement running from the Licensee's purchase date. Removed the prohibition on use in work supplied to third parties and the requirement for a separate written agreement to do so. Clause 5 now permits use of a publication as part of advisory, consulting, or implementation services the Licensee provides to its own clients, provided the publication is adapted for the engagement and is not itself supplied to the client as a standalone FRW product. Clause 6 was updated to prohibit supplying the unmodified publication as a deliverable rather than prohibiting professional use of it.	Executive Authority
2	2026-08-10	Introduced product classes: Pack Product, Individual Resource, and Free Resource. The clause 4 grant now scopes by class, so a Pack Product licenses all of the Licensee's Sites while an Individual Resource licenses the Nominated Site only. Consulting use under clause 5 is limited to Pack Products, with a matching prohibition in clause 6. Clause 10 now terminates the license automatically if the purchase is refunded, and clause 11 ends the revision entitlement with it. The Free Resource class is defined but reserved; FRW has issued none. Clause 12 no longer requires a publication to cite a revision of this license. The governing revision is fixed at supply and identified in the release package manifest and release record, so a revision of this license no longer requires every publication to be reissued. Citations to the pattern, product standard, and template a publication was built under are unaffected and continue to name a revision. As before, a revision of this license does not alter the terms under which any publication already supplied was licensed.	Executive Authority
